Course Objectives and Learning Outcomes:

- To critically examine the historiography of the Pacific War with reference to the problems of historical evidence, memory, interpretation, authentication and the political manipulation of history.
- To analyze and reappraise the current trend towards historical revisionism in Japan, China, The Republic of Korea, the U.S., and elsewhere, and to evaluate 'history as identity' which lies at the core of such attempts to normalize the past.
- To analyze English language writings produced during recent years that touch on or focus directly on the issue of war responsibility and to clarify the boundaries of the Japan Germany comparison.
- To analyze the distinction between public history, commemoration and celebration, and to explore the role of the public intellectual as an interpreter of the past.

Midterm paper: Due (by 12:00 PM)

Select one of the following:

(I) Among the survivors of the Hiroshima bombing were three prominent authors (Òta Yốko, Hara Tamiki, and Tốge Sankichi). Each would later bear witness to their experience of the bomb in the form of first person accounts published between 1945 and 1952. These pieces are contained in Hiroshima Three Witnesses by Richard Minear. Each student is required to write a 6-8 page critical review of either 'Summer Flowers' by Hara or 'City of Corpses' by Òta. Among the questions you might consider are: How did the author view themselves? How did the author perceive the city of Hiroshima and its inhabitants before/after the bomb? How did the author view the government, government officials, the enemy? How, if at all, does the author deal with

survivor guilt? Did the author's perspective change as a result of their experiences? If so, how?

OR

(II) In January 1938, the Akutagawa Award winning novelist Ishikawa Tatsuzō spent time with and interviewed soldiers of the Imperial Army in the recently conquered city of Nanjing, China. The result of this experience was a piece entitled Ikite iru heitai (Soldiers Alive). As special correspondent for the prestigious journal Chūō Kōron (Central Review), Ishikawa had unfetterd access to soldiers of the Shanghai Expeditionary Force. Publication of Soldiers Alive, however, was suppressed, and Ishikawa himself was questioned by the Special Higher Police. Ikite iru heitai was not, in fact, published until 1945. Each student is required to write a (6-8 page) critical response to this piece. Among the questions you might consider are: What does this piece reveal about Japanese attitudes toward China? How is the title of the piece reflected in the experiences and characters of the main protagonists (e.g. Kondō, Hirao, Kurata, Kasahara and Nishizawa)?

Final Research Project (Deadline: First Week of the Examination Period)

Each student is required to submit a 12-15 page research paper that addresses a specific issue or set of issues related Memory of the Pacific War. The topic may focus upon a particular event (e.g. Nanjing) or events, it may be comparative, or it may focus on a single nation or sub-national group. Students are required to submit an initial proposal to the instructor during the week after the Spring Break. A first draft is due by , when I will hold individual tutorials with each student to discuss their progress. The deadline for submission of the final draft will be during the examination week. (Examples of previous projects include: 'The Pacific War Remembered in Peruvian Textbooks', 'Changing Perceptions of Japanese War Stragglers', 'The Pacific War in Chinese Comics'.)

Use of Internet sources: As a rule of thumb, if a site URL ends in *edu*, then it is likely to be a legitimate academic source. Government and NGO sites are likewise reliable sources of information. If in doubt as to the reliability of an Internet source, check with the instructor. <u>The</u> use of Wikipedia is prohibited.

Plagiarism: The use of previously published/written (including your own) material without appropriate acknowledgement, constitutes plagiarism and will result in a failing grade for the course.

Student presentations (): Each student is required to make a presentation (10-15 minutes) outlining their research paper and discussing how this research has challenged, reconfirmed or changed their views of the Pacific War.

This is an intensive reading and writing course. The reading lists are extensive, but by no means exhaustive. Students are expected to familiarize themselves with the required readings in their entirety, so as to participate in discussions.

Format: seminar, lecture, films

You will be issued with reading lists for each session (see below), as well as further items you may wish to consult. The seminars, films and lectures are intended to complement one another, and students will be required participate fully in all discussions. This is an intensive reading and writing class, and preparation is essential. Media presentations represent an important vehicle for the transmission and legitimation of historical memories. Films, ranging from documentaries to excerpts from feature films, therefore constitute an integral part of this course.

Texts:

This course draws upon an extremely wide range of primary and secondary materials. In an effort to reduce costs, books have, wherever possible, been placed on reserve, or relevant chapters uploaded to BrightSpace. There are, however, three core text listed below that you may wish to purchase. All are available through the SUA Library (4-hr. reserve) or may be purchased at Amazon. With the exception of the Roy monograph*, all have been published in paperback.

NB: An excellent online source for materials related to historical memory and the Pacific War is the Asia-Pacific Journal, Japan Focus.
